## What you need to know

- We'll transfer your pension as cash, unless you tell us otherwise in section 2 and 3. Not all pension providers will allow you to transfer your investments. If this is the case we'll sell all your investments and transfer as cash.
- You can transfer up to two pension accounts using this form.
- If you wish to transfer only a part of your pension, please make sure there is enough cash available. If you're transferring your pension as is, please let us know the investments to be transferred.
- If you want to transfer part of your drawdown account please contact our pensions experts before completing this form on **0117 980 9926**.

## What happens next?

- If you're transferring your entire pension account, we'll sell any investments remaining, unless you tell us otherwise in section 2 and 3. It's cheaper to sell your investments on our website. All you need to do is:

- We'll let your new provider know you're transferring and ask them for the details needed to transfer your pension.
- When your new provider sends us the details, we'll arrange for your pension to be transferred.
