Operative provisions

- 1. Pursuant to Clause 4.1 of the Existing Provisions the Principal Employer removes the Outgoing Trustee as a Trustee from the Scheme with the effect from the Effective Date.**
- 2. The Principal Employer will liaise with the Continuing Trustees and the Scheme's registered administrator to ensure all reasonable steps are taken to remove the Outgoing Trustee from the Trusts of the Scheme and any of the assets of the Scheme held in the name of the Outgoing Trustee (jointly or alone), including the removal of the name of the Outgoing Trustee from any relevant registration at HM Land Registry.**




