Dear Miss Lenette

As part of this practice's essential care of people with diabetes, we are inviting you to take advantage of this important opportunity for **photographic eye screening**. The screening service is free and confidential and available for those aged 12 and over.

A screener from the Diabetic Eye Screening Service will be visiting Stroud Road 11-27 March and Quedgeley 2-19 April. To arrange a suitable appointment please telephone the Receptionist at your surgery on 01452 385555 after 11am and tell them when you ring that your appointment is for Diabetic Eye Screening.

At this clinic the Screener will check and photograph your eyes for the presence of a condition known as Diabetic Retinopathy. **You will need to have drops in your eyes to dilate your pupils and this may affect your ability to drive for 2-6 hours.** Please bring all your usual spectacles. You may like to bring sunglasses to wear to go home, as everything may look very bright. Please read the enclosed leaflet for all the essential patient information. Your appointment will take between 30-45 minutes. Even if you have had your eyes screened before, have recently had your eyes examined or if you have a pending hospital eye appointment, it is still important to attend this session.

As someone with diabetes you will appreciate how important it is to monitor all aspects of your disease and eye care is part of this. We would strongly advise you to take advantage of this opportunity to attend for eye screening but if you are thinking of not participating, please would you discuss this carefully with your GP first or, if you choose, with us. If you still do not wish to participate please contact us on 08454 222173/2216 and we will send you an opt out form which you will need to return to us as we cannot accept telephone requests. This will result in offers of appointment ceasing for the period you specify in the form. Your details will be removed from our active list. This is a serious decision and we recommend that you make it only when you fully understand the risks involved.

We may contact patients who do attend their diabetic eye screening appointment about research projects that are taking place in our department in the future. If you do not want to be contacted about research, please inform the screener when you attend for screening.

If you are unable to attend the clinics at your surgery please telephone us on **0300 422 2173 or 0300 422 2216** as we can offer you an appointment at a clinic in Stroud and Cheltenham or alternatively in Gloucester where we also hold early evening and Saturday clinics. We hope you will take advantage of this opportunity to attend for eye screening as it is an essential part of your diabetes care.

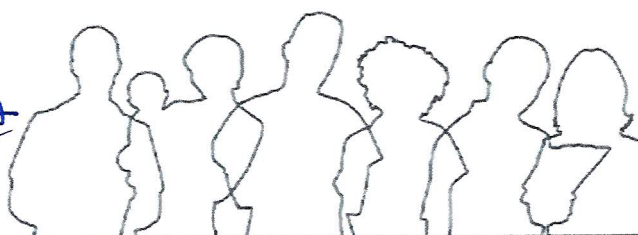

YOUR DRIVING LICENCE

Thank you for your recent application for a driving licence in which you made certain declarations about your health.

We must now make confidential enquiries about your medical fitness to drive cars and motorcycles.

What You Must Do:

Fill in the medical questionnaire and the consent/declaration form and return them to us using the enclosed envelope. **If you do not give us all the information we need including the full name, address and telephone number of your GP/Consultant then there will be a delay with your case.**

Important Note

If you do not fully fill in and return the medical questionnaire and consent/ declaration form within 21 days your driving licence will be revoked or your application refused.

When we receive the filled in forms we may also need to contact your doctor or specialist for a medical report. If you already hold a driving licence, we advise you to speak to your doctor or specialist about driving while we are completing our enquiries.

~~When our medical enquiries are complete you will be notified of the result. You can appeal against our decision if we revoke or refuse your driving licence or if we offer you a short period driving licence.~~

If you passed your driving test before 1st January 1997 and your driving licence has to be revoked or restricted in any way, you will lose your entitlement to drive medium size vehicles, minibuses (category C1/D1 vehicles) and minibuses not for hire or reward, unless you can also meet the higher health standards required for professional drivers.
