Deed of Appointment of Trustee

Parties

- 1 **DJP Bury Ltd** (Company No. 08402259) whose registered office is situated at 59 Bury Road, Dagenham, Essex, RM10 7XR (in this deed called the "Principal Employer")

Recitals


- (A) **DJP Bury Pension** (in this Deed called the 'Scheme') is a pension scheme which is now governed by a Definitive Trust Deed and rules dated 15 May 2014 (in this Deed called the 'Existing Provisions') and all subsequent amending documentation.
- (B) The Continuing Trustee is the present trustees of the Scheme.
- (C) It is intended that the New Trustee be appointed as trustee of the Scheme


Operative provisions



- 2 The parties agree to take all reasonable steps to vest in the Continuing Trustee and the New Trustee the trusts of the Scheme and all of the assets of the Scheme.
- 3 The provisions of this deed shall have effect on and from its date.


