### 1 REVOCATION

I declare that this Will is not to be revoked by my intended marriage to **ALEXANDRA PERRIN** of 31 Hadrians Close, Stratton St Margaret, Swindon, Wiltshire, SN3 4BE and will remain effective irrespective of whether or not that marriage takes place and all former Wills and Codicils made by me are revoked by this Will with the exception of the Will I made in Spain on 7<sup>th</sup> September 2004

### 2 APPOINTMENT OF EXECUTORS

- (a) I APPOINT the said **ALEXANDRA PERRIN** to be my Executrix and Trustee of this my Will
- (b) References to "my executors" include anyone who acts as my personal representative.

### 3 BURDEN OF INHERITANCE TAX

If inheritance tax, or any other form of death duty, is payable on my free estate then my executors must pay it from the residue of my estate.

### 4 RESIDUE

I give to my executors:

- I. my estate, anywhere in the world; and
- II. any property over which I have a general power of appointment; to hold it on trust:
- a. to pay my debts, taxes and funeral and testamentary expenses;
- b. to pay the residue to the said **ALEXANDRA PERRIN** absolutely if she survives me by 28 days; but if this gift fails
- c. to divide the residue equally between those of my children who are living at my death; except if any of my children die before me, then to divide that child's share equally between those of his or her children who are living at my death and attain 18

# 5 TECHNICAL CLAUSES

- a. The Standard Provisions of the Society of Trust and Estate Practitioners (1st edition) apply, amended as follows:
  - (i) Standard provision 5 ("trust for sale") does not apply.
  - (ii) My executors may exercise their powers without consulting beneficiaries, so section 11 of the Trusts of Land and Appointment of Trustees Act 1996 does not apply.
- b. My estate is to be divided as if any person who dies within twenty eight days of my death had predeceased me.
