Deed of Appointment of Trustee

DP Construction (Swindon) Pension Scheme

- 1. **DP Construction (Swindon) Ltd** (company number: 08926097) whose registered office is situated at Nystad, Boyn Valley Road, Maidenhead, Berkshire, SL6 4EL (in this Deed called the "**Principal Employer**"); and
- 2. Aleksandra Ducker of Nystad, Boyn Valley Road, Maidenhead, Berkshire, SL6 4EL (in this Deed called the "New Trustee").

## Background

- (A) DP Construction (Swindon) Pension Scheme (in this Deed called the "Scheme") is a pension scheme which was established and is currently governed by a Trust Deed dated 20<sup>th</sup> April 2014 and all subsequent amending deeds (in this Deed called the "Existing Provisions").
- (B) The Principal Employer is the present sponsoring employer to the Scheme.
- (C) Ian John Ducker, formerly of 31 Hadrians Close, Swindon, Wiltshire, SN3 4BE (in this Deed called the "Former Trustee"), has, following his passing on 14<sup>th</sup> February 2022, ceased to act as a trustee to the Scheme, leaving the Scheme without any trustees in place.
- (D) The Principal Employer wishes to appoint the New Trustee as a Trustee to the Scheme.
- (E) In this Deed (including the recitals) "Effective Date" means the date of this Deed.

## **Operative provisions**

- 1. Pursuant to Clause 4.1 of the Existing Provisions the Principal Employer appoints the New Trustee as a Trustee to the Scheme with the effect from the Effective Date.
- 2. The New Trustee accepts the appointment and agrees to be solely vested with the Trusts of the Scheme and the assets of the Scheme.

- 4.
