David is spending a lot of money refurbishing and equipping Dudley, and we have produced sample products that several supermarkets like and we are getting some indications of likely orders. Bolton also has one very large potential customer that we are making progress with. That factory is ready to go, but unless there is going to be something like £20m of annual sales, it is not really viable. We bought the assets so cheaply that we could sell everything and get our money back, if these large contracts founder.
