### TRUSTEES RESOLUTION

# **Parties**

Paul Hague, Sarah Hague (the "Trustees and Member Trustees"), Cranfords Trustees Limited ("Independent Trustee")

# **BACKGROUND**

- 1. Istrat Limited Pension Scheme (in this deed called the "Scheme") is a registered pension scheme for the purposes of Part 4 of the Finance Act 2004 and currently governed by Scheme rules adopted by a Resolution dated 8 November 2017 (in this Resolution called the 'Existing Provisions').
- 2. The Trustees are the present Member Trustees of the Scheme.
- 3. Under the Existing Provisions and subject to Rules 6.2 and 6.3, the Trustees may regulate their proceedings as they think fit and may make decisions by written resolution or in a meeting or in any other way.
- 4. Under the Existing Provisions the Independent Trustees must ensure that a person who satisfies the criteria in section 270(2) of the Act is appointed as the Scheme Administrator at all times.
- 5. The Independent Trustee shall retire as Independent Trustee and Scheme Administrator.
- 6. All powers and duties vested in the Independent Trustee shall be vested in the member trustees jointly and severally.

# **RESOLUTION**

In accordance with the Existing Provisions, the Trustees have Resolved that:

The cash sums held by the Independent Trustee shall be paid in the form of a pension commencement lump sum to Paul Hague equal to 25% of his share of fund.

On completion of this payment, Cranfords Trustees Limited which is acting as Scheme Administrator and Independent Trustee shall be discharged and removed as Scheme Administrator and Independent Trustee.

Paul Hague declares that he is fit and proper person, with working pensions knowledge to act as Scheme Administrator in replacement of Cranfords Trustees Limited and shall, meet the requirements imposed on the Scheme Administrator under the Finance Act 2004 and registration requirements with the Pensions Regulator.

AJ Bell & Co Limited shall be notifed by Cranfords Trustees Limited of their removal and shall no longer have authority to the share dealing account.

Any third party services providers which Cranfords Trustees Limited has appointed from time to time in connection with the Scheme shall be removed from acting for the Member Trustees and Scheme.
