## Recitals

- (B) The Member Trustee and the Independent Trustee are the current Trustees of the Scheme.
- (C) The Outgoing Principal Employer is the current Principal Employer to the Scheme.
- (D) Under Clause 12.2 of the Existing Provisions, the Trustees, with the agreement of the Outgoing Principal Employer, may by deed substitute any other employer as the Principal Employer, providing that the employer in question covenants to comply with those provisions of the Rules which apply to the Principal Employer.
- (E) The Trustees are desirous to appoint a new Principal Employer to the Scheme and the New Principal Employer consents to their appointment as evidenced by their execution of this deed.

## Operative provisions

- 1. In exercise under Clause 12.2 of the Existing Provisions the Trustees admit the New Principal Employer to the Trusts of the Scheme to replace the Outgoing Principal Employer in all their powers and functions as Principal Employer.
- 2. The Outgoing Principal Employer consents to their replacement as the Principal Employer to the Scheme,
- 3. The Trustees will undertake all amendments to ensure proper implementation of the changes to the Trusts of the Scheme as required by the Existing Provisions.
- 4. The New Principal Employer undertakes to perform in all their functions and exercise their powers in accordance with the requirements of the Existing Provisions.
- 5. Unless the context requires otherwise, meanings assigned to words and expressions in the Existing Provisions shall apply to words and expressions not otherwise defined in this deed.

The provisions of this deed shall have effect on and from its date.
