Please allow up to five working days for your payment to reach your account.

By direct debit - pay monthly on the 1st, 7th, 15th, 23rd or last day of the month

Simply call 0114 273 6633 and tell us your bank details or alternatively see www.sheffield.gov.uk/home/Council-Tax and follow the instructions. All payments are guaranteed. Payments should be made as shown overleaf until you are told the direct debit is set up.

By debit card - 24 hours a day, 7 days a week

Call 0114 273 5249 or pay online at www.sheffield.gov.uk/home/Council-Tax. You will need your card with you and must quote your account number 75912093.

By PC or telephone banking

By PayPoint

You may pay by **cash only** at any PayPoint outlet using your bar coded bill or any other document you have received which has a bar code on it. This service is free. Please keep your PayPoint receipt.

At the Post Office® - you may pay at any Post Office® using your bar coded bill or any other document you have received which has a bar code on it. This service is free. Payment can be made by **cash or debit card**. Please make cheques payable to Post Office Ltd. Please keep your Post Office® receipt.

Pay in 12 instalments?

You are now able to pay your Council Tax in 12 monthly instalments. If you wish to pay this way, applications must be received **in writing no later than 18th March 2022.**

The number of instalments will reduce for any applications received after this date.

Adult Social Care Precept

For adult social care authorities, council tax bills show two percentage changes: one for the part of the overall change attributable to the adult social care precept, and one for the part attributable to general expenditure.

You can manage your Council Tax account online using our E-Citizen self service facility. To be able to use our online services you must register as an E-Citizen. The Direct Debit Guarantee



- This Guarantee is offered by all banks and building societies that accept instructions to pay Direct Debits
- If there are any changes to the amount, date or frequency of your Direct Debit, Sheffield City Council will notify you 10 working days in advance of your account being debited or as otherwise agreed. If you request Sheffield City Council to collect a payment, confirmation of the amount and date will be given to you at the time of the request
- If an error is made in the payment of your Direct Debit, by Sheffield City Council or your bank or building society you are entitled to a full and immediate refund of the amount paid from your bank or building society
- If you receive a refund you are not entitled to, you must pay it back when Sheffield City Council asks you to
- You can cancel a Direct Debit at any time by simply contacting your bank or building society. Written confirmation may be required. Please also notify us.
