- 2 The Administrators accept the appointment for the purposes of Part 4 of the Finance Act 2004 and will undertake those responsibilities in respect of any period from and including 6th April 2006 for the discharge of all duties relating to the Scheme which are imposed on the scheme administrator and/or the maintenance of the registered status of the Scheme under Part 4 of the Finance Act 2004.
- 3 The liability for the payment of any and all taxes, scheme surcharge payments, unauthorised member and employer payments as defined by Part 4 of the Finance Act 2004 (as amended) shall vest with The General Trustees.

The Parties to this Deed agree that the liability of Bespoke Pension Services Limited will be limited to the assets of the Scheme from time to time.

The provisions of this appointment have effect on and from its date.
