#### Re: MMS Executive Pension Scheme

Please note that the above client has received the enclosed letter from Barnett Waddingham. In the last year prior to the move to Pension Practitioner.com, Barnett Waddingham have been asking me for pension details going back fifteen years. When I said to them that I did not think we had the information, they told me that they were not interested and they wanted me to go and find the information. I did provide them with it and I asked them why they were going back fifteen years and they came back to me with 'we are reviewing something'. The client sought Barnett Waddingham's advice back in the year ended 5 April 2014 about a principal employer further pension contribution. They did not do it off their own backs, they did it following receiving the advice from Barnett Waddingham, albeit it was from Trevor Harvey who has since left. In addition to the request they also asked me for a whole years' worth of MMS Executive Pension Scheme bank statements. I have not sent them the bank statements as we had already submitted to them the accounts and I had questioned the reason why. There is nothing in there that I do not want to be seen, but the client was further aggravated by me asking for the information again. This obviously elicited the move to Pension Practitioner.com and any insight into what response we should be making to this letter would be great.

I am herewith enclosing the bank statements for the year ended 5 April 2018 and I have already forwarded to you the accounts.

#### M M S Executive Pension Scheme

We have recently received confirmation from Registered Scheme Administrator that you have decided to appoint them in place of us as your Independent Trustee and Scheme Administrator. I am sorry to hear this, but feel this would be an opportune time for me to bring you up to speed on some work that we have recently carried out on your scheme.

#### Test against the Lifetime Allowance at age 75

When a member reaches age 75 we are required to test the value of their benefits against the Lifetime Allowance which was in place at that point in time. The Lifetime Allowance is the limit on tax-efficient monies which can be accumulated in all pension arrangements for a person during their working lifetime.

As Caroline attained age 75 on 26 May 2017 and you attained age 75 on 9 August 2017 we should have requested a valuation of the scheme assets at these dates in order to carry out the test against the Lifetime Allowance for each you. I cannot see that this calculation has been prepared, and it is mandatory, so we should therefore carry this out retrospectively and we have started work on this for you.

We have identified a potential tax issue for both of you relating to the value of your respective shares of the fund when you attained age 75. This is connected to the contribution of £75,000 paid to the pension scheme in the year to 5 April 2014.

Since both you and Caroline were already "pensioners" in respect of the benefits you switched on before April 2006, from the point that a new contribution was paid into the scheme for each of you in 2014 you would each then have two separate arrangements within the scheme. The first representing your pre April 2006 crystallised funds and a new pot representing the Post April 2006 funds, starting from the £75,000 contribution paid on 24 February 2014.

The form of the test is that at age 75 a value needs to be placed on those pre April 2006 benefits. The calculation is to multiply 80% of the maximum drawdown pension at age 75 by a factor of 25. That figure is then compared to the member's Lifetime Allowance. If the figure exceeds the Lifetime Allowance, then any new benefits which are "crystallised" are subject to a tax called the "Lifetime Allowance Charge".

We have calculated that the notional value of Caroline's pre April 2006 pension at age 75 is:

Maximum pension at age 75 = £60,490 80% of maximum pension = £48,392 £48,392 x 25 = £1,209,800

The Lifetime Allowance for Caroline at age 75 was £1,000,000. This means that Caroline is deemed to have used up the whole of her Lifetime Allowance with her Pre April 2006 benefits.

We do not hold all the asset valuations as at 9 August 2017 to finalise the calculations for you but on reviewing the information we do have I would expect that you will be in a similar situation.

At age 75, any funds from which benefits have not been switched on ("crystallised" in the jargon) are tested against the Lifetime Allowance. For both you and Caroline this test will be against your Post April 2006 fund created by the contribution paid in 2014.

As at 26 May 2017 we calculate that the value of the Post April 2006 funds for Caroline was £46,576.65. As things stand, since Caroline's available Lifetime Allowance has been extinguished by the deemed value of the pre April 2006 funds, the amount of £46,576.65 exceeds the Lifetime Allowance and will be subject to the Lifetime Allowance Charge.

The amount in excess of the Lifetime Allowance is subject to a tax charge of 25% with the remaining 75% retained within the scheme in order to provide a pension, subject to income tax. In Caroline's case the tax due would be £11,644.

This additional deemed usage of the Lifetime Allowance is considered to happen on your 75th birthdays so 26 May 2017 for Caroline and 9 August 2017 for you. The Lifetime Allowance charge for Caroline should have been settled by 14 August 2017 and for you by 14 November 2017. Interest and penalties could be imposed for late submission of the relevant returns and the late tax payment.

In order to confirm the position for you could you please provide me with copies of the scheme bank statements showing the cash balances held as at 9 August 2017.

#### **Protection**

It would be possible to reduce the amount of the tax charge. You could both choose to register for a new form of protection against the Lifetime Allowance, which allows you to use a slightly higher Lifetime Allowance. If a member registers for "Fixed Protection 2016" they retain a Lifetime Allowance of £1.25 million instead of the standard £1 million. The price of this protection is that no contributions to this or any other pension scheme can be made after 5 April 2016.

In Caroline's case, if she is eligible and registers for this form of protection, the tax charge will be reduced to £1,581. In addition, with this protection, Caroline would be entitled to draw a portion of her newly crystallised funds as a tax-free lump sum, when she chooses to do so. Note that this would not be the usual 25% of the "uncrystallised" fund, as there would be a slightly reduced amount available, reflecting that a small portion of the funds exceeded her Lifetime Allowance.

If either of you would like to apply for Fixed Protection 2016, this has to be done online by you; unfortunately, we cannot register for you. You can access the online service through a link on the GOV.UK guide 'protect your lifetime allowance' page at <a href="https://www.gov.uk/guidance/pension-schemes-protect-your-lifetime-allowance">https://www.gov.uk/guidance/pension-schemes-protect-your-lifetime-allowance</a>.

To apply online, you will firstly need to have an HMRC Online Services Account. To create an account, or to login to an existing one, you should go to <a href="https://www.gov.uk/log-in-register-hmrc-online-services">https://www.gov.uk/log-in-register-hmrc-online-services</a>.

As this is an online service, you will no longer receive a paper certificate with your lifetime allowance protection details. Instead you will be able to view your protection details online, and you will be able to print off your protection details for our records.
