- Did you know...

You have until 3.30pm every working day to make sure there's enough money in your account to pay any direct debits or cheque payments due that day. You can pay in cash at an Immediate Deposit Machine or transfer money by Online Banking. And as long as it reaches your account by 3.30pm you could avoid any unnecessary charges.

We pay standing orders from your account shortly after midnight at the start of the due date, or the next working day if the due date is a non-working day. If you have insufficient funds in your account to pay a standing order, we will attempt the payment again the following working day and for up to 23 days in total. We may charge a Returned Item Fee if we are unable to pay the standing order at the second attempt (please refer to your account conditions for information on the fees that apply).

If you pay enough money into your account before midnight at the end of the due date, you will not be charged by us, but you may be charged a late payment fee by the recipient. If this happens, please let us know - we will be happy to refund the fee for you. You can call us on 08457 20 30 40, or pop into your local branch.
