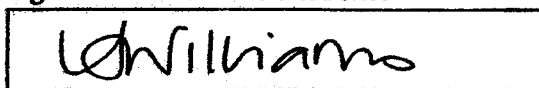

Conditions

This certificate is issued subject to the following conditions. It is an offence to fail to comply with any of the conditions below. Maximum penalty for non-compliance: six months imprisonment and/ or a fine.

- 1 The holder must, on receipt of the certificate, sign it in ink with his usual signature.
- 2 The holder of this certificate must inform the chief officer of police by whom the certificate was granted within seven days of the theft, loss or destruction in Great Britain of the certificate.
- 3 The holder of the certificate must, without undue delay, inform the chief officer of police by whom the certificate was granted of any change in his permanent address.

- 4 (a) The firearms and ammunition to which the certificate relates must at all times (except in the circumstances set out in paragraph (b) below) be stored securely so as to prevent, so far as is reasonably practicable, access to the firearms or ammunition by an unauthorised person.
- (b) Where a firearm or ammunition to which the certificate relates is in use or the holder of the certificate has the firearm with him for the purpose of cleaning, repairing or testing it or for some other purpose connected with its use, transfer or sale, or the firearm or ammunition is in transit to or from a place in connection with its use or any such purpose, reasonable precautions must be taken for the safe custody of the firearm or the ammunition.

Additional conditions may be added here by the chief officer of police.

5. The .22 Rifle serial number 254-26191, .17HMR Rifle serial number 703-52345 and .17HMR Sound Moderator serial number NVN and the ammunition shall be used for shooting vermin and any other lawful quarry and for zeroing on ranges, or land over which the holder has lawful authority to shoot.
6. The certificate holder may possess, purchase or acquire expanding ammunition, or the missiles of such ammunition, in the calibres authorised by this certificate and use only in connection with: (a) the shooting of vermin or, in connection with the management of any estate, other wildlife.
