Re: Equity Total Return Swap Confirmation

The purpose of this letter agreement (this "**Confirmation**") is to confirm the terms and conditions of the equity swap transaction entered into between Red Bridge Capital (UK) Limited ("**RBC UK**") and RBC Pension Scheme ("**RBC PS**") as of the Trade Date specified below (the "**Transaction**"). This letter agreement constitutes a Confirmation as referred to in the ISDA Master Agreement specified below. 
