Deed of Amendment
governing the
Rocky Asset Management Limited Pension Scheme

Parties

1. **Yates Drywall Ltd** (Company No. **08260706**) a company registered in England and Wales whose registered office is at Pentecostal Church Cemetery Road, Wombwell, Barnsley, South Yorkshire, S73 8HY (in this deed called the '**Principal Employer**')
2. **Adam John Yates** and **Helen Yates** both of 57 Red Kite Avenue, Wath-upon-Deerne, Rotherham, S63 7FF and **Wayne Crossland** of 3 Park View, Shafton, Barnsley, S72 8PY (in this deed called the '**Member Trustees**')

Recitals

- 1) Rocky Asset Management Limited Pension Scheme (in this deed called the '**Scheme**') is a pension scheme which is currently governed by a Definitive Trust Deed and Rules dated 22 October 2014 and all subsequent amendment deeds and resolutions (in this deed called the '**Existing Provisions**').
- 2) It is intended that powers of amendment and powers of appointment and removal of trustees, currently vested with the Independent Trustee, will now be vested with the Principal Employer.


Operative provisions

1. Pursuant to clause 3.1 of the Existing Provisions and subsequent amendments and resolutions, the following amendments will be made:
 - 1.1 The power in Rule 3.1 (Power of Amendment) may be exercised by the Principal Employer.
 - 1.2 The power in Rule 4.1 (Power of Appointment and Removal of Trustees) may be exercised by the Principal Employer.
2. The provisions of this deed shall have effect on and from its date.


