- The Principal Employer hereby appoints the New Trustees to the Scheme with effect from the
 Effective Date and in accordance with clause 4.1 of the Existing Provisions. The New Trustees
 consent to their appointment.
- 3. The New Trustees and Outgoing Trustee agree to vest in the New Trustees the Trusts of the Scheme and all assets of the Scheme.
