The fee has already been taken so once the forms come back the transfer can proceed. The last thing was the Member had emailed Adam to get him to pay the fee. I told Adam that the fee had been paid, and the member would pay it whether we retained the scheme or not.

This was left with Adam so he can discuss how to proceed with Robert. It May be worth Chasing it up with Adam at some point.


