## **Operative Provisions**

- 1. The Principal Employer under the power vested in them by Clause 5.3 of the Existing Provisions hereby appoints the Incoming Independent Trustee as a professional trustee to the Scheme.
- 2. The Principal Employer under the power vested in them by Clause 5.3 of the Existing Provisions hereby removes the Outgoing Independent Trustee from its position as a professional trustee to the Scheme.

- 3. The Trustees agree to remove the Outgoing Independent Trustee from the Trusts of the Scheme and any of the assets of the Scheme held in the name of the Outgoing Independent Trustee (jointly or alone), including the removal of the name of the Outgoing Independent Trustee from any relevant registration at HM Land Registry.
- 4. The Trustees agree to vest jointly in the General Trustees and the Incoming Independent Trustee the Trusts of the Scheme and the assets of the Scheme.
