It should be noted for the record, that Pension Practitioner. Com revised their fee structure from £800 + VAT (£960) for the establishing trustee and £400 + VAT (£480) for any additional trustee appointments, to a set fee of £880 for the establishing trustee and £440 for any additional trustee appointments during the financial year 16/17.

Regarding the client holdings in Powerscourt Land Investment, please see a below brief explanation of events:

- Pension Practitioner.Com and Carlton James Administration were appointed to the pension scheme when a fund allocation into Powerscourt Land Investment had previously been established
- Upon review, the Powerscourt Land Investment has not made any returns to the scheme as per information received by the trustees
- Due diligence obtained online indicates an investment failure; no insolvency practitioners have been appointed
- Options are being considered to report a nil balance of investment value
- Investigations are still pending
