**Deed of Change of Scheme Name** 

SELLEC (SPECIAL CABLES) LTD PENSION SCHEME

## **Parties**

1. STEPHEN RON HOOLE (in this deed called the 'Trustee') of Flat 5, The Observatory, 402 Fulwood Road, Sheffield, S10 3GD

## Recitals

- (A) SELLEC (SPECIAL CABLES) LTD PENSION SCHEME (in this Deed called the 'Scheme') is a pension scheme which is now governed by a Definitive Trust Deed and rules dated 26 January 2008 and all subsequent amending documentation (in this Deed called the 'Existing Provisions').
- (B) As a consequence of the liquidation of the Principle Employer and the removal by deed/resignation of Hazell Carr Pensions Services Limited as Scheme Administrator and Named Party from the Existing Provisions, the Trustee remains the sole party to the Existing Provisions.
- (C) The Trustee, by way of Trustee Resolution, has assumed responsibility for the administration and management of the scheme.
- (D) The Trustee may, in exercise of the powers vested in them by the Existing Provisions and by way of Trustee Resolution, amend by deed the Existing Provisions.
- (E) The Trustee wishes to change the name of the Scheme to "Sellec Pension Fund".

## Operative provisions

- 1. In exercise of the powers vested under Clause 3.2 of the Existing Provisions, the Scheme shall be known with effect from the date of this deed as Sellec Pension Fund.
- 2. The Trustee will undertake all amendments to scheme records, including those lodged with HM Revenue & Customs and the Pension Regulator to ensure proper implementation of the changes to the Trusts of the Scheme.
- 3. Unless the context requires otherwise, meanings assigned to words and expressions in the Existing Provisions shall apply to words and expressions not otherwise defined in this deed.
