Hi Georgina,

Mr Methley was only ever a Trustee and not a member.

When the scheme was set up Mr Stephen Hoole and Mrs Kay Hoole were members. Mrs Hoole transferred her benefits in 2007.

Mr Hoole has crystallised his funds and I've attached his Post BCE statement for your records. He originally partially vested his fund 30/11/2008 and is now fully vested with effect from 01/11/2013.

The next statutory review is due 30/11/16 and the GAD max is currently £30,332.21.

As Mr Hoole is the only member of the scheme it is not registered with The Pensions Regulator.

I hope this clarifies matters for you.
