DEED OF APPOINTMENT OF PENSION FUND NEW TRUSTEE

1. DATE: 30 Hr May 1991

2. PARTIES:

- (1) STEPHEN WARD PHOTOGRAPHY LIMITED whose registered office is situate at Ryecroft, 25 Manor Park Road, Glossop, Derbyshire (the "Principal Company")
- (2) STEPHEN WARD and SANDRA WARD both of The Red House, Water Lane, Hollingworth, Cheshire (the "Continuing Trustees")
- (3) PERSONAL PENSION TRUSTEES LIMITED whose registered office is situate at Howard House, 10 Albert Embankment, London, SEl 7SP (the "New Trustee")

3. RECITALS:

3.1. This deed is supplemental to an Interim Trust Deed (the "Interim Trust Deed") made the 30th March 1987 between (1) the Principal Company and (2) Continuing Trustees and Pensioneer Trustees Limited (the "Retiring Trustee") and to a Trust Deed ("the Trust Deed") made the 24th July 1989 between (1) the Principal Company and (2) the Continuing Trustees and the Retiring Trustee whereby the Principal Company established and constituted the Stephen Ward Photography Directors Pension Scheme (the "Scheme")

3.2. The Principal Company wishes to exercise its powers to remove the Retiring Trustee from Office and appoint in its place the New Trustee.

3.3. The New Trustee has agreed to act as such trustee in accordance with the terms and conditions contained in the Interim Trust Deed and the Trust Deed and the Continuing Trustees have agreed to continue to act as trustees with the New Trustee all of which is testified by the execution of this deed by the New Trustee and the Continuing Trustees.

4. OPERATIVE PROVISIONS:

4.1. Pursuant to Clause 10 (a) of the Trust Deed the Principal Company removes the Retiring Trustee from office as a trustee of the Scheme.

4.2. Pursuant to Clause 10 (a) of the Trust Deed the Principal Company appoints the New Trustee as trustee in place of the Retiring Trustee to act jointly with the Continuing Trustees for all the purposes of the Scheme
