**adopting replacement provisions governing the**

**THE MILL CPE EXECUTIVE PENSION SCHEME**

## **Parties**

1. **MILL CPE (LONDON) LIMITED** (registered in England No 06356578) whose registered office is at 11A Bell Yard Mews, Bermondsey Street, London, SE1 3TN (in this deed called the "Principal Employer")
2. **CHRISTOPHER GREGORY ORR** and **ZEYNEP DEVRIM AYHAN** both Flat 2, The Paragon, 43 Searles Road, Southwark, London, SE1 4YL ("Trustees")

## **Recitals**

- 1) **THE MILL CPE EXECUTIVE PENSION SCHEME** (in this deed called the 'Scheme') is a pension scheme which is currently governed by a Definitive Trust Deed and Rules dated 3<sup>rd</sup> April 2014 (in this deed called the 'Existing Provisions').
- 2) It is intended to replace the Existing Provisions in their entirety.
- 3) Under Clause 18.1 of the Existing Provisions, the Principal Employer may with the consent of the Trustees by deed amend the Trust Deed and any Schedules to the Trust Deed (including the Rules).

## **Operative provisions**

1. Pursuant to clause 18.1 of the Existing Provisions, those Existing Provisions shall cease to have effect and the Scheme shall be governed by the attached Rules:

## **PROVIDED THAT:**

1.1 the power in Rule 3.1 (Power of Amendment) may be exercised by the Principal Employer with the consent of all of the Trustees.


1.2 the power in Rule 4.1 (Power of Appointment and Removal of Trustees) the Principal Employer with the consent of all of the Trustees.

The provisions of this deed shall have effect on and from its date.
