Your request to transfer your pension

We've recently received a request from Fenwick Solicitors to transfer your pension to The Mill CPE Executive Pension Scheme.

As scheme trustees, we have both the right and the duty to carry out checks on new schemes or schemes that aren't known to us. In some circumstances, this could delay your pension transfer.

Ultimately, we may not be able to transfer your pension but we will take into consideration any supporting documentation that you may provide.

Supporting documentation would include:-

- Details of the receiving scheme's trustees (their names and addresses).
- Details of the financial adviser who advised you and their FCA authorisation number.
- A copy of any letters, emails, brochures or other marketing materials that you've received from that provide information about the scheme and its charges

We enclose a leaflet from The Pensions Regulator on the possible risks associated with transferring your pension.

If you still want to transfer your pension, we need you to confirm this in writing within 21 days. We won't proceed with the transfer without this.
