- 1. The Employer, in exercise of the power invested in them by the Existing Provisions, hereby appoints the New Independent Trustee to the position of Independent Trustee with effect from the Effective Date.
- 2. The New Independent Trustee consents to their appointment.
- The Member Trustee hereby covenant to act together for the purposes of the Scheme.
- 4. The Scheme Assets are vested in the Member Trustee jointly with the New Independent Trustee with effect from the date of this deed.
