I hope you are well.

There is a beneficiary pension payment of £12,000 due to be paid to Mrs Janet Madin on the 1 July 2021. As there are currently insufficient funds in the scheme Metro payroll account and we have received a signed Deed of Removal to remove our services we assume you no longer require this service.

The payroll account will be permanently ceases on Monday.

If Mrs Madin would like to receive this pension payment before the payroll account is permanently ceased we require funds from the scheme Lloyds account to be transferred to the Metro account, to ensure there are sufficient funds in the payroll account and all outstanding fees settled. This currently total's £990 not including the following charges.

The fee for restarting pension payments is £125 plus VAT and for an ad hoc pension paid outside the usual quarters will incur a charge of £100 plus VAT.
