Instruction

In accordance with your verbal instructions, we have reviewed our previous supplied rental valuation in respect of the above property and have pleasure in reporting to you.

We would refer you to our full report and rental valuation dated 15 May 2001 and subsequent update rental valuation dated 3 May 2005, addressed to your company, providing our opinion of rental value on the basis of market rent.

This letter should be read strictly in conjunction with the above mentioned report, our rental valuation having been carried out using the same criteria.

For the sake of clarification, we attach an Ordnance Survey extract showing the boundaries of the property, edged in red, for identification purposes only.

Property

The property comprises a stone built, part rendered, two storey textile mill, under a fully underdrawn pitched concrete tiled roof, together with two single storey interconnecting extensions, each with a flat felted roof.

Total net usable internal floor area 348.93 m² (3,756 sq ft)

Total gross internal floor area 409.12 m² (4,404 sq ft)

We carried out a full inspection of the property and note that little has changed aside from the resurfacing of the car parking / yard area since our last inspection in May 2005 the building having been adequately maintained over the intervening period.

The premises occupy a total site area of 0.05 hectares (0.12 acres) approximately, which includes a surfaced yard and car parking area to the north of the building which we understand is shared with a neighbouring occupier and subject to a joint rights of way access.

Services

We have not tested any of the service installations. The property is connected to the following main services:

- Water
- Drainage
- Gas
- Electricity

The premises are heated by way of a series of pipes and radiators fed via two separate gas fired central heating boilers, one serving each floor. We are unable to confirm that they are free from any defect.

Condition

We have not carried out a structural building survey and therefore cannot make any comments regarding the structural stability of the building.

The general condition and state of repair of the building is reasonable the property being in a good decorative order throughout. Due to the traditional construction type of the building, it will incur a higher maintenance cost when compared to modern equivalents. Accordingly, an ongoing programme of maintenance should be undertaken to prevent deterioration to the building structure.

We have taken into account the age and general condition of the building in arriving at our rental valuation.

Contamination

An environmental site assessment has not, to our knowledge, been undertaken.

We understand that the original construction was for the textile trade industry. Some textile processes are classified as contaminative and accordingly there is potential for historic on site contamination to have occurred. However, properties with similar industrial histories are frequently sold throughout West Yorkshire for continued industrial and commercial use, and our rental valuation takes into account such open market transactions.

We do not consider the current use of the property, to be significantly contaminative.

The property lies in an area of mixed use, with a range of occupiers to include commercial, industrial and residential uses. We are not aware of any of the adjoining buildings or land having been used for a purpose which may be regarded as contaminative.

Tenure

We understand that the property is held by way of a 999 year ground lease with Kirklees Council, the majority unexpired, at a fixed nominal annual ground rent.

We have not had sight of the title deeds for the ground lease, and cannot therefore make any comment in respect of the specific covenants contained therein.

Tenancies

The property is occupied in its entirety by The Leadership Factor Limited on a formal lease for a term of years certain which commenced in June 1998.

Under the terms of the lease, the tenant covenants to keep a good tenantable repair for the whole of the property and to decorate both externally and internally at regular intervals. In addition the tenant is responsible for the payment of buildings insurance, all services consumed and rates, in addition to the rent.

The current passing rent is £22,000 pa, and is reviewable on a 3 yearly pattern on an upward only basis.

We have not had sight of the lease and cannot therefore make any comments in respect of the covenants contained therein.

Planning

The adopted Unitary Development Plan for the Kirklees Metropolitan Area indicates that the premises are situated within an area unallocated for a specific use.

We understand that the existing use for office will fall within Classes B1 of the Town & Country Planning (Use Classes) Order 1987. We have assumed that all planning consents and licences required for its current uses are in place.

Lease Terms

It is common practice for commercial and industrial properties to be let by way of a full repairing and insuring lease, ie the tenant is responsible for all maintenance and repairs in respect of the building structure. Whilst the original building is quite old, it has been extended and refurbished to provide relatively good standard of office accommodation on ground and first floor. Generally the property is in good condition. Accordingly, it would be unreasonable to expect an ingoing tenant to accept a full repairing and insuring lease, although possibly subject to a schedule of condition, in that the tenant would not be expected to maintain the property in a better state than existed at the commencement of the term.

Our rental valuation assumes that the property will be let on the open market for the remaining duration of the lease term, incorporating a regular rent review pattern of 3 yearly pattern. The majority of commercial leases are granted on such terms.

In our opinion, the market rental value of the property as at the date of this letter amounts to the sum of £25,000 (twenty five thousand pounds) per annum.

The above rental is exclusive of all services consumed and business rates. We anticipate that a landlord will continue to pay the buildings insurance, although will recover the appropriate premium from a tenant as additional rent.

The above valuation has been undertaken in accordance with the recommendations of the Royal Institution of Chartered Surveyors (RICS) Valuation Standards.
