  them enabling hereby remove the Outgoing Trustee as a Trustee and Pensioneer Trustee of
  the Scheme with effect from the Effective Date and with effect from that date the Outgoing
  Trustee shall be discharged from all future duties and liabilities as a Trustee and Pensioneer
  Trustee of the Scheme.
- The Continuing Trustees agree to take all reasonable steps to remove from the Trusts of the Scheme and any of the assets of the Scheme held in the name of the Outgoing Trustee (jointly or alone), including the removal of the name of the Outgoing Trustee from any relevant registration at HM Land Registry.
