The Shareholding has consequently changed for year end.
 Dominic Threlfall - 57.98% from March 2022 (previously 58.80%)
 Tracy Threlfall - 42.02% from March 2022 (previously 41.20%)

Other points to note:

7. Included within the income for the year - Pebley Beach reimbursed the Scheme Fees which were erroneously being paid by the Pension Scheme since inception - £17,910 (Included were also any Banking arrangement fees that the Pension Fund incurred for Loan's back to Pebley Beach Ltd.)

I do have invoices for all of these, but assumed you will not need them.

All future scheme fees are now being debited from Pebley Beach.

8. There is some land notated in Balance Sheet "Land at Wroughton £31,810" – this will be sold as part of a larger land sale I'm finalising. Indicative sale proceeds will be £100,000, should be completed in June 2022... Do I need to involve you with the sale, or can the Trustees (wife and I) sign all the documentation?
