- 5. If any of the assets are properties please explain the nature of the property or properties, i.e. are they residential or commercial and provide a copy of the lease or leases.
- 6. Can you confirm that where rents are due to the scheme that they have been paid in accordance with the relevant agreements. If rents have not be paid in accordance with the

agreements please advise what amounts are outstanding and the period they relate to also advising what action the scheme has taken or is taking to rectify the position.

- 7. If any of the assets are loans please provide a copy of the loan agreement(s) if the loan(s) were advanced post 5 April 2006, plus documents evidencing the security for the loan. If any loan or loans were advance prior to 6 April 2006 but not reported to this office, please also provide a copy of the loan agreement(s).
- 8. In respect of any loans can you confirm that all money's due under the loan agreements have been paid in accordance with the agreements since the loan(s) was advanced. If there are repayments outstanding please advise what the amounts are and the period they relate to broken down into capital and interest. Please also explain what action the scheme is taking/has taken to recover the debt.
- 9. It the assets are shares, please say whether they are quoted or unquoted. In respect of these shares please advise the name of the company, the type/class of shares, the number of shares acquired and sold and the purchase/sale price.
- 10. The names and National Insurance Numbers of the members.
