Pursuant to Rule 10.3 of the Existing Provisions, those Existing Provisions shall cease to have effect and the Scheme shall be governed by the attached Rules, PROVIDED THAT:

- 2.1 the power in Rule 3.1 (Power of Amendment) may be exercised by the unanimous decision of the Trustees.
- 2.2 the power in Rule 4.1 (Power of Appointment and Removal of Trustees) may be exercised by the Principal Employer.

The provisions of this deed shall have effect on and from the date of this deed.
