BACKGROUND

- (A) The Universal Group Executive Pension Fund (the "Scheme") is governed by a Trust Deed and Rules dated 31 December 2009 (the "Rules").
- (B) Clause 8.1 of the Rules says that trustees may by deed remove a trustee of the Scheme.
- (C) Kevin Douglas Boyle and Daniel Williams (the "Outgoing Trustees") are to be removed as trustees of the Scheme with effect from the date of this deed.

OPERATIVE PROVISIONS

Discharge and vesting

The Continuing Trustees consent to the discharge of the Outgoing Trustees in respect of acts or failures to act occurring after the date of this deed and to the vesting of the trust property of the Scheme in the Continuing Trustees with effect from the date of this deed (the "Effective Date").

2. Removal of Outgoing Trustee

The Continuing Trustees remove the Outgoing Trustees as trustees of the Scheme with effect from the Effective Date in accordance with clause 8.1 of the Rules.

3. Continuing Trustees

From the Effective Date, the trustees of the Scheme are the Continuing Trustees.

4. COUNTERPARTS

This deed may be executed in more than one counterpart, which will together constitute one deed.
