- 3. Henry Francis Mostyn Owen Jodrell of Church House Farm, Easton Grey, Malmesbury, Wiltshire, SN16 OPF (in this Deed called the 'Continuing Trustee')

Recitals

- (A) WWP Trustee Scheme (in this Deed called the 'Scheme') is a pension scheme which is now governed by a Definitive Trust Deed and Rules dated 4th March 2015 and all subsequent amending documentation (in this Deed called the 'Existing Provisions')
- (B) The Outgoing Trustees are present Trustees of the Scheme.
- (C) The Principal Employer wishes to remove the Outgoing Trustees of the Scheme under clause 4.1.1 which vests the power of removal in the Principal Employer.
- (D) In this Deed (including the recitals) "Effective Date" means the date of this Deed.
- (E) As a consequence of the removal of the Outgoing Trustees of the Scheme, the Trusts shall remain vested in the Continuing Trustee.

Operative provisions

- 1. The Principal Employer in exercise of the power conferred on them by 4.1 of the Existing Provisions and all other powers them enabling hereby removes the Outgoing Trustees as Trustees of the Scheme with effect from the Effective Date.
- 2. The Outgoing Trustees consent to their removal as evidenced by their execution of this Deed.
- As a consequence of the removal of the Outgoing Trustees of the Scheme, the Outgoing Trustees are
 discharged from the office of Trustee with effect from the Effective Date and the Trust shall be
 vested in the Continuing Trustee.
- 4. The Continuing Trustee agrees to take all reasonable steps to remove from the Trusts of the Scheme and any assets of the Scheme held in the name of the Outgoing Trustees (jointly or alone), including the removal of the name of the Outgoing Trustees from any relevant registration at HM Land Registry.
