## HOW TO PAY YOUR COUNCIL TAX BILL



### BY DIRECT DEBIT

The council offers various dates for payment by direct debit. This is the most effective way to pay. If you would like to set up a direct debit please call 0300 456 0109.

If this bill specifies that your payments will be collected by Direct Debit no further action is necessary.



### BY TELEPHONE

You may make payment using the council's automated payment line 24 hours a day, 7 days a week, by debit or credit card, by telephoning 0300 456 0119. You will need to quote your account reference number and confirm the amount you are paying together with your card details.



### BY POST

Cheques must be made payable to WILTSHIRE COUNCIL. Please provide your name, account reference number and the address to which the payment relates on the reverse of the cheque. If posting your payment please send to:

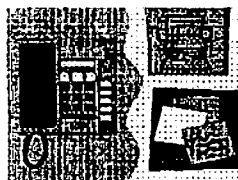
### AT A POST OFFICE

You may pay, free of charge at any post office using your existing payment card or the barcode on the front of this bill. You should allow seven days for your payment to reach us by the instalment due date. Cheque payments should be made payable to 'Post Office Ltd' and presented with your payment card or this bill. Please refer to your bill to confirm the amount of each payment.



### PAYMENT VIA THE INTERNET

Payments can be made via our website at [www.wiltshire.gov.uk](http://www.wiltshire.gov.uk). You may use your credit or debit card to make payment via the Internet. Please allow five days for your payment to reach the council.



### PAYMENT BY BACS OR ONLINE BANKING

In order for you to arrange payment by BACS or online banking, you will be required to supply the following details:

- 1) Wiltshire Council's bank, the HSBC at 46 Fore Street, Trowbridge, Wiltshire, BA14 8EL
- 2) The Sort Code is 40-44-33
- 3) The Account Number is 51460021
- 4) You must also quote your account reference number in addition to the above details.

**Please note that payments must arrive by the dates specified on your bill. Any delay in providing payment may result in the issue of a reminder notice.**
