## Whiteforest Executive Pension Scheme

We are in receipt of the Deed of Removal and Appointment to change the Independent Trustee, however in order for us to proceed further please confirm back the requirements within our letter.

Rowanmoor Executive Pensions Limited currently prepares the annual Pension Scheme Return (PSR) and the new Administrator will need to take responsibility for this in future. The PSR for the year ended 5 April 2019 has not been completed.

Please advise if you will complete and submit the PSR or whether the Trustees require Rowanmoor Executive Pensions Limited to do so prior to your appointment as Administrator.

The reregistration must be completed within three months of the date of the Deed of Removal and Appointment and after this we will charge for any work in relation to re-registration of assets on a time spent basis with a minimum charge of £50 plus VAT.
