Deed of Adherence

In relation to the

Whittingham SSAS

Parties

1. **JVAM Limited** (Company No. 08304065) whose registered office is situated at 20 Park Avenue South Harpenden AL5 2EA (in this deed called the 'Principal Employer') and
2. **James Mark Whittingham** and **Victoria Anne Whittingham** both of 20 Park Avenue South Harpenden AL5 2EA (in this deed called the 'Trustees') and
3. **JVAM OPCO Limited** (Company No. 14324514) whose registered office is situated at 20 Park Avenue South Harpenden AL5 2EA (in this deed called the 'New Participating Employer')

Recitals

- (A) **Whittingham SSAS** (in this deed called the 'Scheme') is a pension scheme which is now governed by a Trust Deed and Rules dated 14th October 2020 (in this deed called the 'Existing Provisions').
- (B) The Trustees are the Trustees of the Scheme and the Principal Employer is the Principal Sponsoring Employer of the Scheme for the time being.
- (C) It is intended that the New Participating Employer shall become a Participating Employer of the Scheme as agreed with the Principal Employer and with the consent of the Trustees in accordance with Rule 22.1 of the Existing Provisions.

Operative provisions

1. Pursuant to Rule 22.1 of the Existing Provisions the Principal Employer with the consent of the Trustees agree with the New Participating Employer that it shall become a Participating Employer. The New Participating Employer agrees that it shall at all times until the determination of the trusts of the Scheme duly perform and observe each and every provision of the Scheme which ought to be performed and observed by it as a Participating Employer for the time being.
2. Unless the context requires otherwise, meanings assigned to words and expressions in the Existing Provisions shall apply to words and expressions not otherwise defined in this deed.
3. The provisions of this deed shall have effect on and from its date.
