I write with reference to previous letters relating to the title of the above property.

The above asset was assigned to you around 2019 and as part of that assignment, it was the responsibility of Registered Scheme Administrator Ltd to re-register the title to the Parkfirst assets with the Scottish Land Registry and notify us promptly when this had been done. Despite chasers, confirmation was never received and a search of the title shows that the Parkfirst investment is still registered in the name of Rowanmoor Trustees Limited. A three year lease tax return will be required in early May 2022 and unless the title is reregistered prior to that date, we will have no option but to file a return to avoid penalties being raised against us. If this occurs we will look to Registered Scheme Administrator Limited to pay our fee of £100 plus vat for dealing with the return.

I would also be grateful for confirmation that you are now urgently taking the re-registration of the Parkfirst properties forward. We will need confirmation of that so that we can file a formal assignation of the lease tax return with Revenue Scotland within 30 days of the re-registrations and so that all future tax returns are the responsibility of yourselves. Furthermore if the reregistration is not forthcoming, we will instruct our solicitors to deal with the re-registration and seek to recover legal fees, admin costs and time spent for dealing with the same.
