Background

- 2. The New Independent Trustee consents to their appointment.
- The parties agree to take all reasonable steps to vest in the Continuing Trustees and the New Independent Trustee the trusts of the Scheme and the assets of the Scheme.
- 4. The liability of the Independent Trustee by Clause 8 is limited at all times to the cash at bank held by the Trustees from time to time.
